Progress Software Named in 20th Annual "Globe 100"

Progress Software ranked among the top Massachusetts-based public companies

BEDFORD, Mass.—May 22, 2008 Progress Software Corporation (NASDAQ: PRGS), a provider of leading application infrastructure software to develop, deploy, integrate and manage business applications, today announced it has been named to the "Globe 100" list of top performing public companies in Massachusetts, for 2008.

Based on a composite score derived from financial data for the four quarters ending December 31, 2007, Progress Software was ranked 46 among Massachusetts-based companies whose stock is publicly traded on NASDAQ, New York Stock Exchange or American Stock Exchange.

To qualify for the Globe 100, a company must have been public for the entire 2007 calendar year and have reported a positive net income for both 2006 and 2007.
